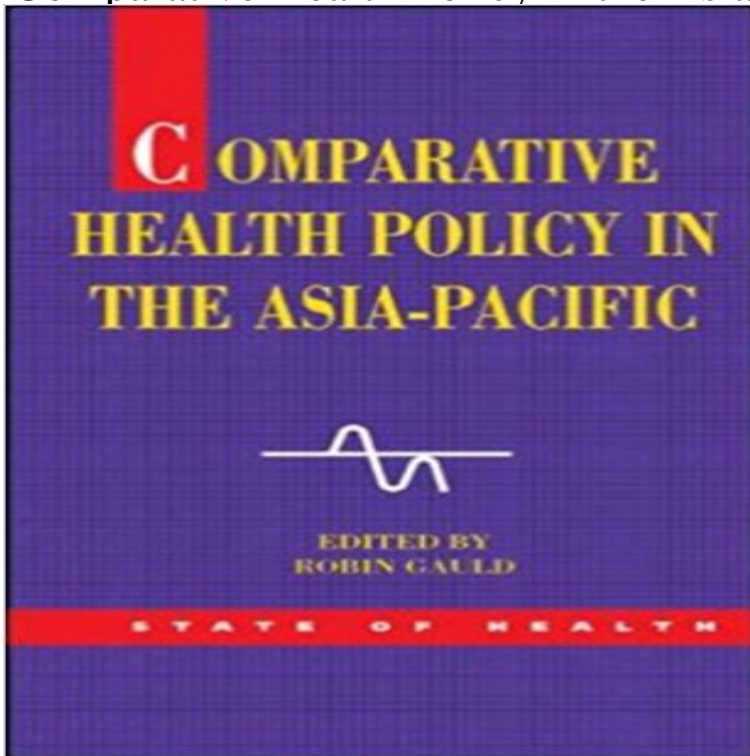


# Comparative Health Policy in the Asia Pacific (State of Health)
