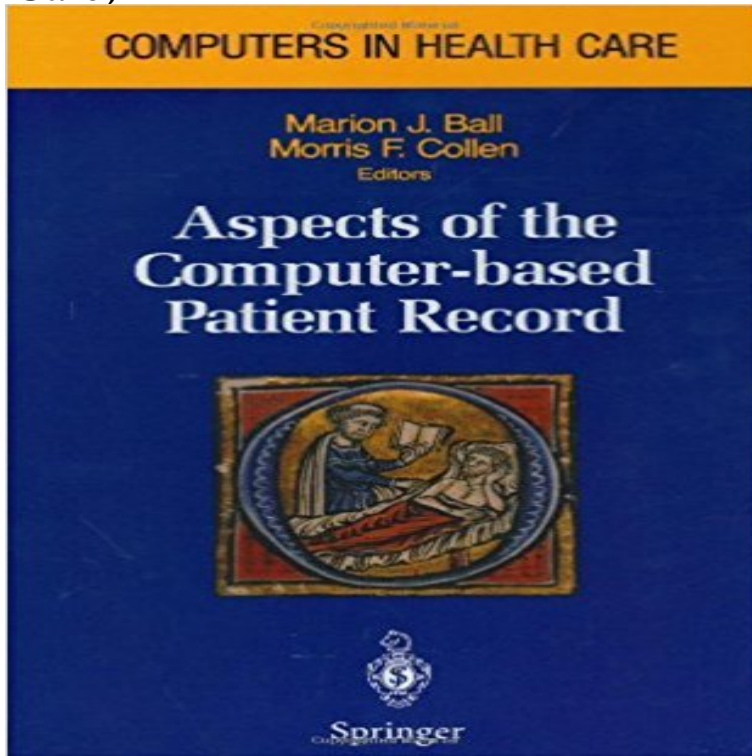


# Aspects of the Computer-based Patient Record (Computers in Health Care)
